I have, however, been able to fill out his President's jacket quite well.

As Club President, I will work with the whole BEAST team to make our trails and your riding experience as fun and enjoyable as possible this upcoming sledding season. All the Board members from the 2013–2014 team are returning. We had one of our longest seasons in recent history, and despite growing pains with the OFSC's Framework for Change, we managed to get through the season and are now about to start another.

During the weekend of September 18-21, 2014, the OFSC held their AGM in Ottawa. This is where all the member clubs get to vote and set policy for the upcoming sledding



season. This year's AGM was about the quietest and fastest voting in recent OFSC AGM's. The biggest news was the freezing of Classic permits at model year 1999 or older for the next five years. At that time, Classics will be 20 years or older. The BEAST team voted against this motion, but the majority won out in the end.

Currently, we are looking into the possibility of upgrading a piece of grooming equipment to help deal with the many water hazards we encounter every year in the BEAST South East sector. Water is a major problem for a 10,000-pound groomer. We need no less than 10 inches of good solid ice to be able to put the groomers out and give you the safe and excellent trails you have become used to; we work very hard to achieve this.

## **BEAST Trail Patrol - By George Laight**

The OFSC Trail Patrol Program commenced in 1983 at the inception of the user-pay system. Trail Patrol members volunteer their time and the use of their personal equipment to be snowmobile ambassadors. These volunteers are clearly identifiable by their Trail Patrol vest, and each member also carries their Trail Patrol ID issued by the OFSC.

The BEAST Trail Patrol comprises over 30 members who patrol during the week, weekends and evenings. Patrols generally consist of two Trail Patrol members but often include 4–8 members. During the 2013–2014 season, BEAST Trail Patrol Members logged nearly 200 hours. We have members stationed all over the BEAST Trail system, including Stittsville, Richmond, Almonte, Barrhaven, Carleton Place and Munster Hamlet.

The primary function of Trail Patrol is public awareness and safety. Trail Patrol members' duties are centred around activity on OFSC Prescribed Trails and may be summarized into four broad categories:

Landowner Agent: As the agent for the landowner, a Trail Patrol has the authority to lay a notice of Trespass to Property charge under the *Trespass to Property Act*.

*Safety Promotion:* Members promote safe riding by reminding snowmobilers of safe riding practices.

Risk Management: Trail Patrol members actively identify and report unsafe or unusual conditions, remove branches and report safety issues to the club.

*On-Trail Support:* Trail Patrol members provide on-trail support in the form of maps, safety equipment, directions, help and updated information on trail conditions.

Members of the BEAST Trail Patrol will be out again this season checking for permits and helping snowmobilers. Our goal is to ensure the trails are safe and everyone is compliant with and aware of the various

## **Driver Training - By Anna Basile**

Ontario Law requires any person 16 years and over to hold a valid Ontario Driver's Licence or a Motorized Snow Vehicle Operator's Licence to operate a snowmobile on OFSC snowmobile trails. Persons 12 to 15 years old require a Motorized Snow Vehicle Operator's Licence.

If this is you, or someone you know, sign up for an OFSC Snowmobile Driver Training course

The OFSC Driver Training Course is designed to emphasize the safe operation of motorized snow vehicles. Upon successful completion of the course, the participant will be legally eligible to drive a snowmobile in Ontario.

The Driver Training Course will be held on November 22, 2014, at the Beckwith Township office. The course will cost \$40, with an extra fee for lunch (optional).

Each student must produce her or his birth certificate, passport or driver's licence upon registration, which must be completed in advance. Registration for the November 22 course will be held on November 18, 2014, from 7-8pm at the Lackey' house (1405 7th Line, Beckwith). PLEASE NOTE: There will be no registration on the day of the course.

## **Volunteering - By Daryl Rauhala**

This is a volunteer run club just like any other OFSC club. Rather than put out the old generic message that we can use a hand, which is always true, we thought that this time around we'd give a few specific examples of how you could improve the local snowmobiling experience and meet some fellow sledders.

These examples encompass the many small tasks that can help offload work from the core volunteers to avoid making club duties feel like a job.

For starters ... are you interested in media? You could help organize next year's newsletter (what you are reading now) or on a weekly basis collect information and send it out as BEAST updates during the season.

More interested in trail tasks? We have been looking to complete the trail intersection distance markings for years with no takers. We have a spreadsheet in progress of the signs and distances and simply need to apply the distance numbers to incomplete intersections. It's no small task, but something to work on at your own pace during the season.

Have some free time in the fall and some farm equipment? Sure would be nice if someone could pack down the majority of the tilled fields where the trail runs before they freeze up!

Don't mind painting? A couple hundred

orange trail pickets disappear or break every year. These need to be ordered, picked up, dried and painted and reflective stapling added. This is another task that can be executed to fit your time frame. We add metal posts every year that stay up year-round, but in many cases only temporary orange wooden posts are suitable.

Eager for an early season ride when the snow first hits? The club needs to pack swamps 10-plus feet wide to drive the frost into the ground before many sections of trail can be used by all. Contacting the sector coordinators at the start of the season can give you a chance to legally ride early without impacting landowners whose land may still be in use for activities such as hunting or harvesting.

Do you have time to enjoy a fair and sell raffle tickets, or man a station at a poker run for a few hours?

Each season for the past several years, BEAST has organized work days that provide an opportunity for people to pitch in and help us get trails ready for the season. Before a groomer can turn a single track, volunteers work to clear brush, patch up bridges, work reroutes and place signs and pickets so riders will know where to go once we are open for business. We have three weekends to choose from, which allows those busy families to get out at least one day. It is truly amazing to see how much work can be done with the additional help we get during these workdays. Not only do you have an opportunity to meet fellow sledders sharing experiences, but it also provides you with invaluable trail knowledge for when snow does hit the ground. One other interesting comment we get is how much the land-scape transforms with the coverage of snow.

Work days usually start around 09:00 with people meeting at a designated location a few minutes early so we can organize work groups. As usual, there are three meeting places to choose from, so pick the one closest to you and come on out!

# **Grooming -** By Jim Lackey

The 2013–2014 season was a groomer operator's dream. Early snow, cold seasonal temperatures to make ice and no real mid-winter meltdowns allowed us to provide close to 10-plus weeks of solid grooming. On top of this, breakdowns and repairs were minimal, so this ensured that a BEAST groomer was active on the trails at all times somewhere throughout the course of the winter. Conditions like this made our job easy to provide some of the best riding experiences seen around here for years, and from various reports, this coming season is projected to be similar to last year.

In total, the BEAST has around 15 regular operators responsible for running four large units and one smaller and lighter unit for the water-challenged areas in the South East sector. So who are these people, where do they come from, and what else do they do?

Well, for the most part, groomer drivers are some of the most die-hard snowmobilers in your club. On top of their regular jobs, before snow even hits the ground, they work many weekends with club volunteers to make sure trails are cleared and marked as per OFSC provincial guidelines. We work closely with BEAST sector coordinators to sort out trail changes or re-routes due to land development or perhaps changes in ownership of property. Mechanical skills and knowledge to deal with pre-

season maintenance and trail breakdowns are an important asset to an operator.

Once the snow hits and it is safe for equipment to roll, it is not unusual to see an operator work 8–10 hours with their regular job, have a quick supper and hop into their groomer unit for another 6–8 hours of grooming. On the weekends, we usually finish up a day's ride by heading straight to the groomer on a Saturday night to ensure smooth trails for Sunday riding. We know what it is like to have great weekend trail riding, so this is a constant cycle throughout the season provided snow and weather conditions allow us to groom

Basically, a groomer operator lives, eats and breathes snowmobiling from the first flake of snow hitting the ground until that last ride of the season. Just look at their house with chores piled up as deep as the snow in their laneway!

With this past season's dump of snow, there were a number of times where you could be sitting beside a nice warm fire watching TV when the phone would ring. Say what? Where are you? How bad is it? What do you need? Before you know it, you are rounding up tools, hopping into a cold truck and heading off to rescue your stranded buddy. Working as a brotherhood, you can usually find a couple other fellow drivers to pitch in on a rescue, as we all know what it is like to be stuck out in the cold.

When training a new operator, a key message is not "if" but "when" you get stuck, this is what you need to do and who to call to get out of a jam. One thing each and every one of us appreciates is getting the thumbs up from riders as they pass by, and we really, really appreciate the riders who stop to see if we need help when a groomer is stopped on the trail. It never hurts to stop and check on us, as it can be a cold and lonely walk to the next road to get help.

To ensure your best riding experience, always make it a habit to check the BEAST website or the OFSC Interactive Trail Guide for trail conditions. We keep these areas of information as current as we possibly can, but one of your best sources of information is to ask a groomer operator direct. We are here to help you enjoy your rider experience by providing some of the best trails in the area.

## North East Trail Sector Status - By Daryl Rauhala

The BEAST North East (NE) consists of trails from Stittsville south-west on the Trans Canada Trail (TCT), BEAST 202, BEAST 201, portions of the A from BEAST 202 southeast to the Jock River, BEAST 303 east to Copeland Rd, and E104A (Ashton swamp between Dwyer Hill Rd and Ashton Station Rd). In general, this section is the high, dry and easiest BEAST sector to access for trail work and overall maintenance. From a trail grooming standpoint, all these trails are covered by the NE BR180. On top of that, the A trail is the NE's grooming responsibility end to end within the BEAST, as well as the BEAST 203 into the north side of Richmond from time to time.

It is pretty much status quo for the NE this season. As we all experience urban sprawl and highway expansion, holding the trails in check is considered a good year. It appears as though Hobbs Meats has closed on Dwyer Hill Rd, so the small access trail there will no longer exist. We do not currently foresee any other trail changes in the

That said, one key area of constant concern is the TCT leading out of Stittsville. This trail is unique as this is a shared section of trail and is controlled by the City of Ottawa. Its yearly status is controlled by city council based on feedback from the public in the context of all shared trails within the city limits. Each year the BEAST enters into a land use agreement with the city and pays a fee for the right to maintain an OFSC trail within the city limits of the TCT. This arrangement will continue if snowmobilers are courteous to other users of the TCT. As this is the only access to OFSC trails out of Stittsville, please be extra cautious here and pass along this message to fellow sledders. Slow down to a crawl when passing other TCT users. There were no complaints registered with council for this section of trail for the last two seasons, so let's all try to keep Stittsville a sled-accessible community and the A trail on the TCT within city limits.

# **Trail Changes**

- Hobbs Meats and Bakery on Dwyer Hill Road, has closed, so the access trail from the A Trail will no longer exist.
- BEAST 309 may be re-routed.

# Help Wanted - By Gord Servant

The BEAST is a not-for-profit association run by volunteers like you. Everyone from the President down to trail maintenance is a volunteer. Without people like you, the organization would not exist. The following roles are currently vacant. Please contact a Board member if you have interest in helping out.

OFSC Response Coordinator (*Alternate*): This role is currently vacant. The candidate will provide assistance to the OFSC Response Coordinator when required.

Health and Safety Coordinator: This role is currently vacant. The candidate will be responsible for maintaining an up-to-date Health and Safety Policy, promote a safe workplace throughout the year and report any concerns or complaints to the Board.

Signage Coordinator: This role is cur-

sponsible for inventory management, training, inspecting and auditing signage throughout the BEAST trail system, as well as reporting and ensuring compliance with OFSC standards.

Inspection Coordinator: This role is currently vacant. The candidate will be responsible for coordinating a signage audit and corrections.

Alcohol Policy: This position is currently vacant. The candidate will review policy annually with the Board in September, communicate our policy to members annually at the AGM and ensure policy material is available for events.

Trail Maintainers: The Club Trail Maintainers assist in conducting maintenance on trails. This includes signage and brushing.

Trail Section Coordinator: The Club Trail Section Coordinator is responsible rently vacant. The candidate will be re- for maintaining an assigned section(s) of

the trail. This includes all aspects of operation for the specified season such as landowner permission, signage and brushing.



## Where do I put my permit?

In support of the OFSC User Pay System, Ontario law requires every recreational sled entering an OFSC Prescribed Trail to have and display a valid snowmobile trail permit.

Before you go out on OFSC trails, ensure you have your permit and it is affixed to your snowmobile. Ontario

Trail Permits are required to travel on OFSC Prescribed Trails. A valid Snowmobile Trail Permit must be affixed to your windshield to ride on OFSC trails. The fine for failing to have a valid permit is not less than \$200 and not more than \$1,000.
